AND WHEREAS, the institution, SHRI S.R. EDUCATION COLLEGE, PLOT/KHASARA NO.: 1030/MIN-4, STREET NO.: NS ROAD, VILLAGE + POST OFFICE: NEWAD, TEHSIL + CITY: NEEMUCH, DISTRICT: NEEMUCH 458441, MADHYA PRADESH (**WRCAPP2949**) has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **245th** meeting held on **March 01 - 03, 2016** is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Sc. B.Ed. Integrated Course. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
